The Ghana Commission for UNESCO is a specialized agency of the Government of Ghana that serves as the official link between UNESCO and Ghana as a Member State of the Organization. UNESCO aims at contributing to global peace and security by promoting cooperation among nations and people through Education, the Sciences (Natural, Social and Human), Culture, Communication, and Information.

In performing its mandate of coordinating the relations between the Government of Ghana and UNESCO, the Commission set out in 2021 to advance international cooperation between Ghana and its partners in UNESCO's fields of competence, promote UNESCO's global agenda and ensure an increase in Ghana's contributions to UNESCO. The Commission has also made an impact with its work through peace-promotion and capacity-building activities.

As an outlook for 2021, we planned to continue to fulfil our mandate but undertake the following activities:

- Promote 2030 SDG Agenda in UNESCO's fields of competence.
- Promote activities within the delivery of quality education, peacebuilding, sustainable development.
- Participate in the 211th, 212th and 213th Sessions of the Executive Board of UNESCO as well as other UNESCO fora.
- > Participate in the 41st General Conference of UNESCO.
- Build the capacity of staff of the Secretariat with the requisite skills to increase productivity.
- > Develop the Commission's Strategic Plan.
- > Acquire an Act of Parliament for the Commission.
- Monitor the implementation of UNESCO's projects in Ghana.

## ABOUT THE GHANA COMMISSION FOR UNESCO

The Ghana Commission for UNESCO is a specialized agency of government with the mandate to foster multilateral relations between UNESCO and its Member States and Ghana. National Commissions are unique institutions found in all Member States of UNESCO.

The Government of Ghana recognizes UNESCO as a long-term strategic partner in support of achieving Ghana's national development plans and priorities.

The Ghana Commission for UNESCO exists to localize the ideals of UNESCO in Ghana through UNESCO's five fields of competence to broker peace. The Ghana Commission for UNESCO works closely with a diverse range of partners – national and regional governments, ministries, departments, and agencies, other UN agencies, international and bilateral development partners, local and international NGOs, local civil society, academia, the media, and communities.

The Commission performs the following functions:

- Acts as an advisory body to the government in determining policies about UNESCO and its programmes.
- Serves as a liaison agency by involving Ministries,
  Departments and Agencies (MDAs) in UNESCO activities
  for the advancement of Education, the Sciences, Culture
  and Communication, with the aim of advancing mutual
  knowledge and understanding of UNESCO's work
  towards the common welfare of humankind.
- 3. Disseminates information from and to UNESCO.
- Exchanges information and experiences with its counterparts in Member States of the Organization.
- 5. Fosters close co-operation between state agencies and services, professionals, and other universities as well General Conferences and other inter-governmental meetings convened by UNESCO, in the preparations of Ghana's position papers by preparing the contribution of Government to the work of these meetings.
- Participates in the search for candidates for vacant UNESCO posts financed under the regular programme or from extra- budgetary resources, and in the placement of UNESCO Fellowship holders.
- Participates in the planning and execution of activities entrusted to UNESCO which are undertaken with the assistance of the United Nations in Ghana.

#### **GOVERNANCE**

The Ghana Commission for UNESCO presently comprises at least thirty-five (35) members drawn from relevant Ministries, Departments, Agencies, institutions as well as non-governmental organizations in Ghana. The Commission meets in plenary session twice a year, preferably March/April and September/October.

The Hon. Minister for Education is the Chairman of the Commission and the coordinating minister responsible for UNESCO Affairs in Ghana. He is the leader of all Ghana's delegation to UNESCO activities.

### **SPECIALIZED COMMITTEES**

There are six (6) Programme Specialized Committees which reflect the main fields of competence of UNESCO in Ghana, namely Education, Natural Science, Social & Human Science, Culture, Communication & Information and Legal & Administration. The members of each of the programme specialized committee are selected from government and non-governmental organizations.

The Committees, comprising nine (9) members each, provide expert advice relating to their sectors and help the Secretariat to prepare draft briefs for Ghana delegations to UNESCO Executive Board and General Conference Sessions. The Programme Specialized Committees meet as and when necessary.

#### **SECRETARIAT**

At the operational level, a National Secretariat is headed by a Secretary-General, who serves as the Secretary to the Commission and the main channel of communication between the Government of Ghana and UNESCO. There are programme officers in charge of the five areas of expertise as well as External Programme Matters and Administration.





## **HIGHLIGHTS OF 2021 ACTIVITIES**

With the impact of COVID-19 still being felt in 2021, the work of the Commission, which normally would involve in-person activities, carried on via remote working for the first quarter of the year.

With the COVID-19 pandemic still raging as we entered 2021, the Commission resolved to carry on its activities utilizing technology for online meetings and later, when the situation permitted, gradually easing into face-to-face activities. We continued to be an active member of the UNESCO Executive Board, joining and contributing to both its virtual and in-person meetings.

We highlight some activities below.



# GHANA'S PRESIDENT VISITS UNESCO

It was a moment of pride for us at the Commission when Ghana's President, Nana Addo Dankwa Akufo-Addo, joined other Heads of States to address the 75th Anniversary of UNESCO in a special ceremony held at the UNESCO headquarters in Paris, France on 12th November, 2021. His speech centred on UNESCO's contribution to Ghana but also Ghana's contribution to UNESCO and to its work globally.

# UNESCO SURVEYS, REPORTS & CONSULTATIONS

It is part of our mandate to ensure Ghana's participation in consultations, surveys and to submit reports on normative instruments.

- Shana successfully completed and submitted her first report on the Implementation of the Recommendation on Science and Scientific Researchers in 2017 through the CSIR-STEPRI.
- The Commission supported the Ministry of Youth and Sports in completing the State Parties Report to the International Convention Against Doping in Sport for 2020 and 2021.
- A survey was completed on the Film Industry in Ghana with the help of the Film Producers Association of Ghana (FIPAG).

### **HIGHLIGHTS OF 2021 ACTIVITIES**

- A survey on Underwater Cultural Heritage was also conducted with the support of the Ghana Museums and Monuments Board (GMMB).
- Shana completed its quadrennial report of the 2005 Convention on the Protection and Promotion of the Diversity of Cultural Expressions.
- We also facilitated the completion of a survey on Public Access to Information (SDG 16.10.2) by the Ghana Statistical Service and the Ministry of Information.

#### STATUTORY MEETINGS

The Commission coordinated Ghana's participation is UNESCO meetings as a member state and as a member of the UNESCO Executive Board. High-powered delegations, led by His Excellency the President and the Honourable Minister for Education, represented Ghana at these meetings in Paris, France where UNESCO is headquartered.

- Biosphere Reserves and Ecosystem Services Integration for Sustainable Development in Ghana - Ghana National MAB Committee (Environmental Protection Agency).

- Establishment of Functional IHP National Committee and Sensitization on Programmes – Ghana National IHP Committee (Water Resources Commission).
- Building a Comprehensive Non-Formal Education Policy -Complementary Education Agency.

#### **NATIONAL COMMITTEES**

National Committees serve to further the work of UNESCO's intergovernmental committees locally. They operate under the auspices of the National Commission. In 2021, the Commission continued its mission to reconstitute and revitalize Ghana's National Committees.

- We reconstituted the National Committee for the Memory of the World Programme to ensure widespread and lasting access to documentary material and the preservation of it.
- We reconstituted and relaunched the National Committee of the International Hydrological Programme.
- The National Committee of the Intergovernmental Oceanographic Commission (IOC) continued its work.
- The National Committee of the Man and the Biosphere (MAB) continued its work.

The National Commission has also met twice in the period under review for its 40/2 and 41/1 meetings.

### PROGRAMME SPECIALIZED COMMITTEES

The Commission successfully organized Programme Specialized Committee meetings to consider, among other things, agenda items of the 211th and 212th Session of the UNESCO Executive Board as well as the 41st Session of the UNESCO General Conference.

# THE GHANA COMMISSION FOR UNESCO ACT

A series of activities were held in our march towards a legislative Act. Our Bill is currently gazetted to be put before Parliament for consideration

### **5-YEAR STRATEGIC PLAN (2022 - 2026)**

The Commission has developed a 5-year Strategic Plan envisaged to commence in 2022. The Plan seeks to strategically position the Commission to make an IMPACT and have INFLUENCE in its areas of competence.

#### **BIDS, AWARDS & PRIZES**

- Together with the Accra Metropolitan Assembly, the Ghana Book Development Council and other partners, the Commission facilitated the preparation of the application dossier of the Ghana Book Development Council for Accra's designation as the World Book Capital for 2023. Accra has successfully been designated as the World Book Capital for 2023 and will put up a series of activities to commemorate the year.
- The Commission also successfully facilitated the designation of the Technology Consultancy Centre of KNUST as a UNESCO Category II of Excellence.



# PROGRAMME AREA HIGHLIGHTS\_EDUCATION

The Commission operates in the areas of expertise that UNESCO has set out for itself. These are, Education, Natural Sciences, Social and Human Science, Culture, Communication, and Information.

Below are some activity highlights.



### **EDUCATION**

The sector is responsible for providing support for Ghana's quest to attain SDG 4 in the areas that UNESCO has expertise in.

In 2021, the conversation towards the accomplishment of SDG 4 continued. The Education Section commemorated the following international days:

## INTERNATIONAL DAY FOR EDUCATION 24th JANUARY

- > The Commission in collaboration with the Institute for Education Planning and Administration (IEPA), Ghana Education Service (GES), and the Ghana National Education Campaign Coalition (GNECC), commemorated the day to take stock of the government's COVID-19 Education Response and Schools reopening: the success, challenges, and lessons learned.
- > A Youth Parliament was organized for students who have completed Junior High School (JHS) to discuss various issues on the theme and create awareness of the day.
- > The Commission further joined other stakeholders in Education (MOE, GES, ILO, UNAIDS, UNESCO, UNFPA, UNICEF, UNHCR, UNU, and WFP) to commemorate the Day on 26th January by issuing a joint statement.

# GLOBAL HANDWASHING DAY 15th December

The Commission supported the McCarthy Hill School to mark the day. Students at the school, with guidance from their teachers, produced liquid soap to donate to their community while creating awareness of the day and the importance of hygiene.



# INTERNATIONAL DAY AGAINST VIOLENCE & BULLYING INCLUDING CYBERBULLYING 4th November

The Commission engaged students of the Bethany Methodist JHS (Dzorwulu), Maamobi Prisons Basic (Roman Ridge), and La Bawaleshie Presby (East Legon) in interactive talks on school-related violence and the whole-school approach in intervening, preventing, and addressing violence in schools.



## WORLD AIDS DAY 1st December

The Commission co-organized an outreach programme with the Ministry of Education, the HIV & AIDS Secretariat, and the Narcotics Control Commission at the Accra Technical Training Centre (ATTC) on December 1, 2021.

The outreach featured talks on drug abuse and addiction and the increasing rate of HIV & AIDS in the country.



# UNESCO CLUB ORIENTATION AT ACCRA TECHNICAL TRAINING CENTRE (ATTC)

The Sector also engaged students of the Accra Technical Training Centre (ATTC) on 14th October in an orientation session to discuss issues on application, membership, and operations of the Club.

# PROGRAMME AREA HIGHLIGHTS\_SOCIAL & HUMAN SCIENCES (SHS)



## WORLD ART DAY



# PROGRAMME AREA HIGHLIGHTS\_CULTURE

The Culture Section of the Commission, in line with UNESCO's aim of ensuring that culture takes its rightful place in development strategies and processes, assists Government agencies, and facilitates programmes that will enable Ghana to fulfill its requirements with respect to the conventions, safeguarding heritage, strengthening creative industries, and encouraging cultural pluralism.

The highlights of the Culture Sector for 2021 are outlined below:

Under the auspices of the Commission, the Ghana Heritage Committee in partnership with MOTAC, GTA, and the French Embassy organized a workshop to validate the first-ever Multi-Stakeholder Heritage Strategic Framework in West Africa for Ghana.
